

Oui & Bouqs.com Sweepstakes Official Rules

NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

1. Eligibility: Oui & Bouqs.com Sweepstakes (the "Instant Win Game") is open only to legal residents of the 48 contiguous (48) United States and the District of Columbia (excluding Alaska and Hawaii) who are eighteen (18) years old or older at the time of entry. Employees, officers, and representatives of General Mills, Inc., The Bouqs Company, Merkle Inc. ("Administrator"), as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible. The Instant Win Game is subject to all applicable federal, state, and local laws and regulations and is void in Alaska and where prohibited. Participation in the Instant Win Game constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's and Administrator's decisions, which are final and binding in all matters related to the Instant Win Game. Winning a prize is contingent upon fulfilling all requirements set forth herein.

3. Timing: The Instant Win Game begins on February 1, 2022 at 12:00 a.m. Eastern Time ("ET"), ends on May 31, 2022 at 11:59 p.m. ET (the "Promotion Period"), and consists of two (2) phases (each a "Phase") as outlined below.

Administrator's computer is the official time-keeping device for the Instant Win Game.

4. How to Enter: During the Promotion Period, you must obtain a code in order to play the Instant Win Game. There are three (3) ways to obtain a code for the Instant Win Game:

Online Free Code Request -- From May 18, 2022 to May 31, 2022: To request a Code online, visit www.OuiMerciBouquet.com and follow the links and instructions to complete and submit the Code request form, including a valid email address, and you will receive a Code within one (1) business day via automated email. All requests must be received by May 31, 2022 at 11:55 p.m. Sponsor is not responsible for lost, late, incomplete, invalid, unintelligible, or misdirected requests, which will not be honored.

Once you obtain a Product Code, during the Promotion Period, visit www.OuiMerciBouquet.com and follow the links and instructions to complete and submit the registration form in its entirety including providing your valid email address. Next, follow the instructions to enter the Code to receive one (1) Instant Win Game play ("Play"). Then, follow the links and instructions to proceed to the Instant Win Game. The Instant Win Game results will be instantly displayed. All potential winners are subject to verification before any prize will be awarded. Administrator is responsible for the functionality of the Instant Win Game. If you are not a potential winner of an Instant Win Game prize, you will receive a promotion code good for 20% off Bouqs.com purchase, terms and conditions apply ("Offer"). Limit: one (1) Offer per person.

Limit: Each entrant may play up to fifteen (15) times during the entire Promotion Period, regardless of method of entry or combination of methods of entry, or Phase. Multiple entrants are not permitted to share the same email address. The "authorized account holder" is the natural person assigned an email address by an Internet access provider, online service provider, Internet service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted address. ONE HUNDRED (100) GIFT CARD PRIZES (eighty (80) awarded during Phase 1 and twenty (20) awarded during Phase 2): A \$25.00 Bouqs.com digital gift code, terms and conditions apply. ARV: \$25.00.

Prizes must be redeemed by winner on Bouqs.com by August 31, 2022. All terms and conditions of Bouqs.com apply. Odds of winning depend on the date/time of entry, the number of prizes remaining available at the time of entry and number of eligible Instant Win Game plays received. The number of prizes available to be won will diminish as they are awarded. No cash or other substitution, assignment or transfer of any prizes permitted, except by Sponsor, who reserves the right to substitute a prize or prize component with cash or another prize of comparable or greater value.
